Below is information about how Farrant Group Limited (“we”) use cookies and similar technology on this website.

This policy is effect as of 29 April 2022. Please note that this policy will be updated from time to time.

1. Cookies and similar technology

- 1.1. A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive.
- 1.2. Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good user experience when you browse our website and allows us to improve our site.
- 1.3. The cookies used on our website have been categorised as per table below:

| Category | Purpose |

| Strictly necessary cookies | These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services. These cookies are essential for the basic operation of our website. |
| Analytical or performance cookies | These cookies allow us to deploy analytics to recognise and count the number of visitors and how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily. |
| Functionality cookies | These are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or log in details). |
| Targeting cookies | These cookies record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. |

2. Third Party Involvement

- 2.1. We have partnered with selected reputable third parties, such as Google Analytics, and others to provide us with web analytics and intelligence about our website through the use cookies, over which we have no control.

- 2.3. The Analytics cookies used by Google Analytics help us improve our website. The information collected by the cookies do not directly identify anyone as each user is recorded as a randomly

| _ga | Used to distinguish users by a unique ID and generate statistical data on the users visit to our website. | 2 years |
| _gid | Used to distinguish users by a unique ID. | 1 day |
| _ga_<container-id> | Used to persist session state. | 2 years |
